Report from the Endowment Fund Trustees

The ASWA Seattle Chapter No. 9 Scholarship Endowment Fund was established to encourage, receive and administer gifts in perpetuity for the purpose of granting scholarships for college and post-graduate studies in the field of accounting.

During fiscal year ended June 30, 2009, the fund received \$4,375.00 in permanently restricted contributions. The fair market value of the principal balance was \$132,092.15. The Scholarship Endowment Fund earned \$5,344.77 during the year. This amount has been transferred to the Chapter's scholarship fund.

The trustees have continued to use the same investment management firm for investment advice. Karen O'Brien and Joe Hebert of TrueNorth Financial Services LLC have agreed to provide the trustees with investment management advice on a pro-bono basis. We very much appreciate their professional assistance.

Hello All: A good friend of mine writes what she calls "The Last Word". Of course, it never is the last word on any subject. Rather it is a reflection on some part of life and how we fit into it. The following is some thoughts about life balance. When I read it, I could not help but reflect on all the ways that the ASWA, and all my friends within this great organization, have helped me achieve a small part of what Karen writes about. The Last Word: Get a Life...

Some thoughts I had after my accident last year.....

Real life is all I know. Don't ever confuse the two, your life and your work. The second is only part of the first. I don't ever forget the words my father told me one year "If you win the rat race, you're still a rat." Or what John Lennon wrote before he was gunned down in the driveway of the Dakota: "Life is what happens while you are busy making other plans."

There will be hundreds of people out there with your same degree; there will be thousands of people doing what you want to do for a living. But you will be the only person alive who has sole custody of your life – Your particular life –Your entire life. Not just your life at a desk or your life on a bus, or in a car, or at the computer. Not just the life of your mind, but the life of your heart. Not just your bank account, but also your soul.

People don't talk about the soul very much anymore. It's so much easier to write a resume than to craft a spirit. But a resume is cold comfort on a winter night, or when you're sad, or broke, or lonely, or when you've gotten back the test results and they're not so good. Here is my resume:

* I am a good mother to two children. I am a terrific grandmother to six grandsons and an "unknown" grandchild (coming soon). I have tried never to let my profession stand in the way of being a good parent and grandparent.

* I no longer consider myself the center of the universe.

* I show up.

* I listen.

* I try to laugh. I don't take life too seriously - my accident taught me that.

* I am a good friend to my friends, and they to me. Without them, there would be nothing to say to you today, because I would be a cardboard cutout standing in the corner. But I call them on the phone.

I would be rotten or, at best, mediocre at my job, if those other things were not true. You cannot be really first rate at your work if your work is all you are. So here's what I want to tell you:

Get a life, a real life, not a manic pursuit of the next promotion, the bigger paycheck, the larger house. Get a life in which you notice the smell of salt water pushing itself on a breeze over the water, a life in which you stop and watch how an eagle circles over the water, or the way a baby scowls with concentration when he tries to pick up a Cheerio with her thumb and first finger. Get a life in which you are not alone. Find people you love, and who love you. And remember that love is
