**Women's History Month** Did you know that March is Women's History Month? This was first celebrated in 1981 as "Women's History Week" and expanded to Women's History Month in 1987 by resolution of Congress. Hannah Adams became the first American woman to support herself by writing in 1784! In 1849, Elizabeth Blackwell became the first woman to receive a medical degree in the United States. Lucille Ball and Pearl S. Buck have been elected to the National Women's Hall of Fame in Seneca Falls, NY which is where the Women's Suffrage movement was formally set into motion in 1848.
